



FEE INCLUDES

AIRFARE: Round trip international air Economy Class from San Antonio. One way Domestic air from Beijing to Shanghai in economy class. All flights include airport taxes & fuel surcharge.

LUGGAGE: Handling fee of ONE piece of checked luggage.

LAND TRANSPORTATION: All transfers arranged by deluxe air-conditioned/ heated coach.

HOTEL ACCOMODATIONS: 3 nights at Beijing Marriott City Wall Hotel or similar; 2 nights at Hangzhou Crown Plaza Xanadu Hotel or similar; 3 nights at Shanghai Renaissance Zhongshan Park Hotel or similar; total 8 nights. Based on double occupancy (\$455 additional for single), includes hotel tax and service.

MEALS: 8 International buffet breakfasts, 5 lunches and 5 dinners with gratuity included. 2 bottles of water daily during tour.

GUIDED TOURS: Assistance of tour escort and Chamber representative throughout the trip. English speaking guide service.

GRATUITY: Gratuity for local guide, driver and escort at \$56 per person.

FEE DOES NOT INCLUDE

CHINA VISA FEE: A valid and current visa is required for all individuals entering China. Visa application service is available for an addition fee of \$200.00*. Please submit the following materials to the Greater San Antonio Chamber of Commerce by 12:00 noon on January 11, 2012 or 12:00 noon February 1, 2012 :

1. Valid passport (with at least six months of remaining validity from date of trip and at least one blank visa page).
2. Signed and completed visa application form (See Visa Instructions form for details)
3. One 2" x 2" black and white or color passport photo.
4. A check payment of \$200 to **The Chamber** (you can also include this in your total payment on p.1 or pay online).

The Visa Application Form is available on the Chamber website. Please print or type your answers in capital English letters and send original hardcopy to The Chamber Attn: Margot Fuentes/ PO Box 1628/ San Antonio, TX/ 78205. Please prepare to be without your passport for up to 30 days after you turn it in to The Chamber. Visas can also be obtained in person at the Chinese Consulate in Houston, Texas. *Visa prices are subject to change if application fee increases.

EXCESS BAGGAGE PENALTY: One piece of checked luggage is allowed when traveling within China. Weight should not exceed 44 lbs. per bag. Any excess weight may incur penalty from the airlines. Individual is responsible for any and all excess baggage penalties.

PERSONAL EXPENSES: Any personal expenses such as telephone bill, laundry, room service, meals or drinks which are not mentioned in the program.

TRAVEL INSURANCE: We highly recommend purchase of travel insurance. Travel insurance is available for purchase through Asia Getaway Inc./ Access America. Information on purchasing a Travel Insurance Plan is available online.

OTHER: Does not include additional services deviating from the itinerary.

TERMS & CONDITIONS

RESERVATION: Reservation should be made through Greater San Antonio Chamber of Commerce. Complete and accurate information of participant including address, telephone number e-mail, passport number and date of birth along with a photocopy of passport is required.

DEPOSIT: A non-refundable deposit of \$250.00 per person is required upon reservation.

PAYMENT: Payment can be made by check, credit card or money order. Checks are preferred form of payment. Full payment is required by January 11, 2012. Payment must be received in full before travel documents will be delivered. Make checks payable to The Chamber.

TAXES & SERVICES: All rates quoted are inclusive of the 15% service charge. Should the government of "The People Republic of China" either increases or decreases the percentage of tax collected; we reserve the right to adjust the rates accordingly.

CANCELLATION POLICY: All cancellations must be received in writing. If cancellation is received before January 12, 2012, deposit of \$250 per person will be forfeited. Cancellations received between January 13-February 12, 2012, 50% cancellation charge to be applied (plus forfeit of \$250 non-refundable deposit).

Cancellations received between February 13, 2012 and date of departure, **100% cancellation charge to be applied. We strongly urge all passengers to purchase cancellation insurance for this program.**

PRICE ADJUSTMENT: We reserve the right to adjust the listed prices at any time should there be a fluctuation in the exchange rate between the Chinese RMB and US dollar or any increase imposed by suppliers such as airlines or hotels. The quotation is based on current exchange rate of US\$1=RMB6.2. We reserve the right to adjust the listed prices at any time should there be a fluctuation in US departure tax and fuel surcharge. The quotation is based on current US departure tax and fuel surcharge at USD320 per person from San Antonio gateway and USD250 per person from Los Angeles or San Francisco gateway.

TOUR ARRANGEMENT: In case of increased number of participants, we reserve the right to use more than one air carrier and hotel to accommodate requests. The Greater San Antonio Chamber of Commerce cannot guarantee room location and type. This tour requires a minimum of 25 participants in order to operate. In the case of fewer participants, passengers will be refunded.
